I. Call to Order

III. Minutes- January 13, 2022

C. Kent made a motion to approve the minutes from January 13, 2022. R. Hegan seconded the motion and it passed unanimously.

VI. Public Hearing

A. PZ#22-1-SUB, Andrew & Kirsten Wotton, subdivision, Walker Road, Woodchuck Hill Road, and Water Street, Map 7, Lot 4.

The Commission opened the public hearing. D. Sorrentino of Boundaries, LLC was present at the meeting. He stated that the abutters were notified, and the public hearing signs were placed on the property. The application was approved by the Inland Wetland and Watercourses Commission. D. Sorrentino stated that the applicant was requesting a waiver of Section 3.12 requiring street monumentation. He explained that six less monuments would be erected than as required by the regulations.

D. Sorrentino stated that the open space requirement did not apply to this subdivision. He explained that the regulations require open space when more than 3 lots are required. As the lot was an existing building lot, the applicant was only creating 3 additional. D. Sorrentino stated that the State Archaeologist recommended that a survey be completed prior to construction. He stated they received a quote for the survey from one company, and another declined. He stated he would leave the decision up to the Commission, but he could notify the State Archaeologist office prior to construction if they felt they needed to review the site.

B. Lamont of 43 Walker Road stated he was told the property was unbuildable. D. Porter-Price of 17 Woodchuck Hill Road asked what the possibility that additional subdivision proposals were applied for on the property. D. Sorrentino stated the wetlands would

make this difficult, and the applicants had no plans that he knew of, but he would not rule this out. C. Essex of 566 asked if the trees on the property would be cleared. D. Sorrentino stated that they would not be cutting any trees.

C. Kent made a motion to close the public hearing. R. Hegan seconded the motion and it passed unanimously.

Boundaries, LLC submitted a letter stating there had been no activity on the property. C. Kent made a motion to approve PZ#22-5-PR. R. Hegan seconded the motion and it passed unanimously. The application was valid until March 1, 2023.
