2023 Declaration of Personal Property - MOTOR VEHICLE FORM

Filing Requirement – This declaration must be completed and filed with the Assessor of the Town where the personal property is located. Declarations of personal property shall be made annually.

Writing "Same as last year" is not acceptable.

Penalty for late filing – Failure to file timely will result in a penalty equal to <u>25%</u> of the assessment of the personal property. This declaration must be filed or postmarked (as defined in C.G.S. Sec 1-2a) no later than

Wednesday, November 1, 2023.

Extension: The Assessor may grant a filing extension *for good cause* (CGS §12-42). If a request for an extension is needed, you need to contact the Assessor in writing on or before **November 1, 2023** (PA 19-200).

If you <u>moved the property out of this town</u>, you must return this declaration to the Assessor and provide information related to where you moved the property (see below). Otherwise, the Assessor must assume that you still own and have failed to declare your taxable personal property. Don't forget to file in the CT town to which you moved!

If you no longer own the vehicle(s) in question, fill out the area below and return proof of the vehicle(s) leaving your possession. Acceptable forms of proof are a bill of sale, junk receipt, total loss letter, trade-in documents, etc. Contact the Assessor's office to discuss the requirements based on your situation or review them here: https://bit.ly/Canterbury Vehicle Disposal Info
