



The Assessor's office is primarily responsible for preparing the Town's Grand List. The Grand List is generated each year in January or February and is a record of all taxable and tax-exempt property as of Oct 1st. Taxable property includes real estate and personal property, including motor vehicles. The office is also responsible for maintaining the assessor maps and data about all properties, and for applying tax exemptions or

reduction programs such as the veterans, disabled, elderly, blind, and PA 490 programs. Please call or email the Assessor for information about these programs.

**Please email or call to make arrangements in advance if you require access to the assessor's records or an appointment for a tax reduction program application.**

When viewing [Mapping Data](#), please be aware that online data may not yet reflect deed or survey map changes filed after October 1, 2022. Changes are typically made annually for the previous tax year. Survey maps filed with the Town Clerk may not be reflected until the following scheduled update.

**Therefore, the tax maps are NOT to be used for legal purposes as accuracy at any given time cannot be guaranteed.**
